Directions to field:

To get to Bucks Mills, take Rte 537/Colts Neck Road (heading east from Freehold or west from Eatontown). Bucks Mill Road is directly across the street from the signpost for Hominy Hill Golf Course. Turn onto Bucks Mill Road and follow slowly about one mile. Make a left into Bucks Mills Recreation Center. Stay on the gravel road through the park. Follow the road as it turns left, past the pond and porta-potties, up a small hill. You'll see the field on your left.

Open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers or dogs enrolled in the AKC Canine Partners program. Females in season may not enter. A dog may enter only once per event. (An event is defined by an event number.)

Any dog not present 5 minutes after their assigned inspection time will be considered absent.

*Dogs will be given time slots (emailed to owners) and asked to show up at least 45 minutes prior for inspection and roll call.

Ribbons & Prizes:

Green rosettes will be given to any dog completing a title

General:

1. All entries must be one year of age or older on the day of the test or trial.
2. Hounds not present at the time of roll call will be scratched after a five (5) minute grace period. Each entry will be examined at inspection. Bitches in season and lame hounds will be excused. Entry fee for hounds excused, during inspection, for bitches in season, lameness or breed disqualification shall be refunded.
3. All hounds running on the 600 yard course will run first followed by hounds running on 300 yard course. *Subject to change
4. Gasoline and electric powered drag lure machines, with back-up equipment, will be used in trials. Lure will consist of white plastic bags.
5. The field committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
6. The field committee reserves the right to bar known aggressive hounds from the event site.
7. There will be a \$5 fine assessed for any loose hound not taking part in the course in progress, or for anybody caught not picking up after their dog or leaving garbage on the field.
8. NO ONE will be allowed on the field without the express permission of the field chairman, except the appointed field committee.
9. Anybody exhibiting unsportsmanlike behavior will be excused from the field and may be subject to further disciplinary action.
10. **Control of dogs strictly enforced, on leash at all times except when running.**
11. **Clean up after you and your dog. Garbage cans will be available.**
12. **Please pick up all dog feces** and remove with trash or put in receptacle provided at site.
